- 1. Secretary's Report (P. Mummaneni)
 - a. Make sure to invite ED's and Presidents of both parent organizations to the Section EC
- 2. Treasurer's Report (C. Kuntz)
- 3. New Business
 - a. CSRF (Collaborative Spine Research Foundation) initiative for OREF/NREF collaboration (Charlie Branch)
 - i. Free booth at annual meeting for 2013 and 2014 was proposed for CSRF
 - ii. Chris Wolfla proposed and Praveen seconded a motion to confirm the free booth for CSRF for 2013 and 2014 and to include CSRF in the NREF Spine Section Cmte.
 - iii. This is a 501c3 organization that is a joint initiative between OREF and NREF set up for independent peer reviewed processes and grants for clinical research issues for large multicenter studies
 - 1. NREF reps are Branch, Shaffrey, McCormick, and Ghogawala
 - 2. surveys were sent out to identify the top clinical research questions that need to be answered
 - 3. Currently, the confirmed grant commitment from Medtronic at this time is \$7 million over 3 years that is contingent upon matching funding from other industry sources (50% first year, 33% subsequent years).
 - a. Without other funding sources the grant will not proceed
 - b. SRS/Section AUC Project for Adult Deformity (Glassman)
 - i. Appropriate Use Criteria (AUC) is a strategy developed by RAND/UCLA which takes expert opinion and reviews it by a panel. This will generate highly valued evidence based guidelines
 - 1. Cardiologists have effectively used this tool
 - 2. Lumbar degen scoliosis is the planned topic
 - 3. RAND will do this and will cost \$600,000.
 - a. Funded by societies and industry through CSRF
 - b. Will take 18 months
 - c. AANS is fully supporting this process
 - ii. Update on N2QOD (McGirt)
 - 1. NPA (501c3) is the national neurosurgery registry and the current project is the N2QOD surgical case registry.
 - a. NPA is run by AANS
 - 2. The registry data will be used to support payments for spinal procedures
 - 3. \$1 million has been invested in the process and 65 people have volunteered time for it
 - a. 500 lumbar spine patients are being enrolled per month at several dozen participating centers

- b. Cervical module will be starting soon
- The prospect is for 10,000 degen spine patients with prospective registry data collection per year will be collected, and this is now underway
- d. A deformity module is proposed in collaboration with SRS (Glassman is SRS president elect)
- c. N2QOD deformity module update (Praveen)
 - i. The proposal is to do this module in collaboration with the SRS.
 - 1. need to plan inclusion/exclusion criteria
 - 2. need to determine what data parameters to collect and what radiographs will be needed
 - ii. SRS: Jeff Coe, Sig Berven, Lloyd Hey, (Shaffrey)
 - iii. Section: Praveen, Matt McGirt, Mike Groff, (Shaffrey)
 - iv. Conference calls are scheduled to work this out
- d. Request for DSPN participation in steroid survey for SCI (Cheng)
 - i. Schroeder in Ortho at Northwestern working with Patel, Eck, Hodges
 - ii. Use of high-dose steroids in acute spinal cord injuries for update on paper by Eck in 2006
 - iii. Joe Cheng asked the EC cmte for input on this survey. Eric Potts will be the cmte member who will take charge of this issue. The EC cmte did not want to proceed with the survey due to survey fatigue amongst the membership.
- e. CAST Accreditation (Volker Sonntag) (Request time at 11:30am).
 - i. Changing name to NCAST (Neurosurgery CAST)
 - 1. they plan to hire a FTE if approved by the SNS
 - 2. Sonntag is representing Spine and Charles Branch is also involved
 - 3. ABNS has approved a 12 month rotation outside the parent institution but will count as a core neurosurgery rotation and not as an elective
 - a. Infolded fellowship is not CAST accredited now, but this may change in the future with NCAST
 - 4. 26 postgraduate Spine fellowships are CAST accredited now
 - 5. NREF will only fund NCAST accredited programs
 - the proposal is the designation of fellowship will be the same with infolded vs post-residency fellowships and post-graduate fellowships will be phased out over time
 - 7. NCAST is asking for help planning this from the Spine Section
 - 8. The Spine Section representatives who will help plan this include: Mummaneni, Trost, Cheng
- f. Developing position statement on physician-owned distributorships (PODs) (Cheng)
 - i. AANS has a COI position statement against PODS. Does the Spine Section want to make a similar statement?
 - ii. Chris Wolfla and Dan Resnick and Katie Orrico pointed out that the regulations regarding PODS from the OIG has yet to be completely clarified.
