I received a call from Dr. James Callahan, Travelers Insurance Company of Hartford, Connecticut. He asked if we had any written assessment on electrical implants in the spinal cord, a procedure apparently done to control pain. He was specifically interested in the pisces-sigma electrode Itrel System. Apparently he needs the information in order to make a determination on a claim.
